## 2017 Society for Advancement of Violence and Injury Research National Conference

### TERMS AND CONDITIONS FOR EXHIBITORS September 18-20, 2017

1. **APPLICATIONS AND ELIGIBILITY:** Applications for tabletop space must be made on the printed form on page 5, contain the information requested, and be executed by an individual who has authority to act for the applicant (exhibitor). Any such exhibitor/producer, supplier, equipment or other products and services representative, whose proposed exhibit will enhance the purposes of the conference, may apply for tabletop display space. The Conference Organizers reserve the absolute right to reject any such application.
2. **AGREEMENT TO CONDITIONS:** Each exhibitor, for himself and his employees, agrees to abide by these conditions, it being understood and agreed that the sole control of the display area rests with the Conference Organizers.
3. **ASSIGNMENT OF SPACE:** Conference Organizers will determine the location for each exhibitor according to the character of the proposed display and individual requirements. Once the Conference Organizers have approved the space, no exhibit will be moved except by the mutual consent of the parties.
4. **PAYMENT:** Full payment must accompany your application. Applications must be received by May 31, 2017.
5. **INSURANCE:** In all cases, exhibitors wishing to insure their goods must do so at their own expense. The Conference Organizers assume no responsibility for tabletop area security or for the value of any goods. All materials supplied by the exhibitor are displayed at their own risk and liability.
6. **EXHIBIT TABLES:** Each table will be six feet in length and include draping. The Conference Organizers will provide no additional materials. If any additional equipment is needed (electrical, signage, wired internet, etc.), it is the responsibility of the exhibitor to work with the conference site and arrange payment for all related activities.
7. **CARE OF SPACE:** The exhibitor is responsible for, at his/her own expense, maintaining and cleaning the area of the exhibit space.
8. **PROTECTION OF EXHIBIT SPACE:** Nothing shall be nailed, tacked, screwed, or otherwise attached to any building structure. If any damage occurs it is at the responsibility of the exhibitor to pay any damages.
9. **DEFAULT OCCUPANCY:** Space must be filled and completed with set-up by noon of the first day of exhibits. If space is not occupied by the designated time, the Conference Organizers have the right to use the space as necessary and no refund will be granted to the exhibitor.
10. **CANCELLATION:** Cancellations must be received by August 31, 2017, and will be refunded less a \$50 administrative fee. No refunds shall be given for any cancellation after August 31, 2017.
11. **LIABILITY:** The Conference Organizers undertake no duty to exercise care, nor does it assume any responsibility for the protection and safety of the exhibitor and its property used in connection with the exhibit, to include theft, damage, and destruction. The exhibitor should remove small and easily removed articles during non-peak convention hours. The Conference Organizers will provide no security of goods.
12. **SCHEDULING:** We encourage you to interact with participants in a manner respectful of the meeting agenda. Please do not schedule events or meetings during sessions.
